Urban Solutions were commissioned to provide construction project management services for the civil works phase of the Selo residential housing development within the Nola Orchard site in West Auckland. The Selo Land Development project has provides an exciting opportunity for Urban Solutions to not only strengthen our relationship with Aedifice Property Group, but also to aid in delivering essential additional housing solutions for Auckland Communities.

Key considerations in project programming for Selo included the requirement for a swift turnaround of procurement and the awarding of the civils contract to Cameron Civil. This allowed the enabling works to kick off earlier than anticipated. Civils were able to commence at the beginning of the earthworks season, utilising the full time window to establish and construct the site in time for building platform handover, April 2022.

The project entailed the delivery of 35 townhouses of which some are included in the Kiwibuild initiative helping provide affordable homes to eligible buyers.



Urban Solutions was engaged by Aedifice Property Group to provide Engineer to Contract services and project management oversight for this project. The Woodglen Road land development site, Woodglen Ridge, incorporated 47 two and three bedroom freehold terrace townhouses of which some are included in the Kiwibuild initiative helping provide affordable homes to eligible buyers.

Urban Solutions provided high level oversight of the contractual and commercial aspects of the contracts and engineer to the contract duties midway through the construction phase of this project.

The site is located on an elevated ridge comprising of shallow to moderate grades falling away from Woodglen Road and presenting unique design considerations. Although the development boasts boutique, architecturally designed modern townhouses, big on comfort, they are also refreshingly affordable, catering to affordable housing stocks in the area.
